(Tabling recommendation for Rejection of
Nubia Pazos)

1 WHEREAS, the Tohono O'Odham Legislative Council did meet to hear
2 out the cases being recommended for rejection on their
3 request for enrollment into the Tohono O'Odham Nation;
4 and

5 WHEREAS, after hearing out the reasons for making such
6 recommendations by the Enrollment Committee the Tohono
7 O'Odham Legislative Council determined that the basis
8 upon which the Committee made their recommendations
9 needed further research.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
11 Legislative Council hereby tables the recommendation for
12 rejection of the person listed, pending further
13 investigation of the Enrollment Committee:


15 The foregoing Resolution was passed by the Tohono O'odham Council

19 in the Council by Section 1 (a) of Article VI of the
20 Constitution of the Tohono O'odham Nation, adopted by the Tohono
21 O'odham Nation on January 18, 1986, and approved by the Acting
22 Deputy Assistant Secretary -Indian Affairs (Operations) on March
23 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
24 Stat. 984).
