

Article IIII of the Enrollment Ordinance.


The foregoing resolution was passed by the Tohono O'odham

quorum was present with a vote of 797.0 for; 431.0 against;  
243.0 not voting; and 169.0 (8) absent; pursuant to the powers  
vested in the Council by Article II and Section 1 (h) of Article  
VI of the Constitution of the Tohono O'odham Nation, adopted by  
the Tohono O'odham Nation on January 18, 1986, and approved by  
the Acting Deputy Assistant Secretary - Indian Affairs  
(Operations) on March 6, 1986, pursuant to Section 16 of the Act  
of June 18, 1934 (48 Stat. 984).
