

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Management of Health Services 3-Month Extension)

RES. NO. 13-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Management of Health Services Program under FY '88 P.L.
3 93-638 contract with Public Health, Indian Health
4 Services; and

5 WHEREAS, such Tribal operations have been successful and
6 beneficial to the Tohono O'Odham Nation and its people;
7 and

8 WHEREAS, the Tohono O'Odham Nation does desire to extend for
9 provisions of these services during FY 1989; and

10 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
11 approved the Management of Health Services Program
12 Budget.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it does authorize and request the Public
15 Health, Indian Health Service to extend the Management
16 of Health Services Contract.

17 BE IT FURTHER RESOLVED that the duration of this extension will
18 commence on January 01, 1989 through March 31, 1989.

19 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
20 that the Tohono O'Odham Nation's officials, to wit; the
21 Chairman, Vice Chairman, and any other designated
22 official are hereby authorized to negotiate and execute
23 this contract and any amendments thereto for the
24 duration of the contract, provided however, that any
25 amendments affecting the funding or funding levels of
26 this contract shall be submitted for further prior
27 approval by this Council.

28 The foregoing Resolution was passed by the Tohono O'odham Council
29 on the 6th. day of January, 1989 at a meeting at which a quorum
30 was present with a vote of 1,582.0 for; -0- against; 58.0 not
31 voting; and 03 absent, pursuant to the powers vested in the
32 Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
