- WHEREAS, such Tribal operations have been successful and beneficial to the Tohono O'Odham Nation and its people; and
- WHEREAS, the Tohono O'Odham Nation does desire to extend for provisions of these services during FY 1989; and
- WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the Management of Health Services Program Budget.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

 Council that it does authorize and request the Public

 Health, Indian Health Service to extend the Management

 of Health Services Contract.
- BE IT FURTHER RESOLVED that the duration of this extension will commence on January 01, 1989 through March 31, 1989.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's officials, to wit; the Chairman, Vice Chairman, and any other designated official are hereby authorized to negotiate and execute this contract and any amendments thereto for the duration of the contract, provided however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 6th. day of January, 1989 at a meeting at which a quorum was present with a vote of 1,582.0 for; -0- against; 58.0 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
