12 WHEREAS, the applications has come on for hearing before this
13 Council; and

14 WHEREAS, the Enrollment Committee did serve written notice of its
15 recommendation to reject the applications and of this
16 hearing, as required by Section 2, Article VI of the
17 Enrollment Ordinance, upon the person(s) who filed the
18 application(s) and such person(s) were not present at
19 this hearing; and

20 WHEREAS, the Tohono O'Odham Council has reviewed all of the
21 evidence presented and from such evidence finds that the
22 applicant(s) has failed to establish the foregoing




The foregoing resolution was DEFEATED by the Tohono O'odham Council on the 2nd. day of May, 1989, at a meeting at which a quorum was present with a vote of 128.5 for; 797.5 against; 556.0 not voting; and 158.0 (04) absent; pursuant to the powers vested in the Council by Article II and Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
