- WHEREAS, the Tohono O'Odham Legislative Council is concerned about the rejections currently being addressed.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby cease addressing Enrollment Rejection issues and refers to the appropriate committees a thorough review of the Enrollment Ordinance.
- BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council will continue to address the names submitted for membership approvals.

The foregoing Resolution was passed by the Tohono O'odham Council on the 2nd day of May , 1989 at a meeting at which a quorum was present with a vote of 931.5 for; 498.0 against; 52.5 not voting; and 158.0 (05) absent, pursuant to the powers vested in the Council by Section 1 (h) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
