## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Law Enforcement Budget Modification)

RES. NO. 145-89

WHEREAS, the Tohono O'Odham Nation is presently operating the Law Enforcement Program under FY 1989 P.L. 93-638 contract with the Bureau of Indian Affairs; and

whereas, any amendments affecting the funding or funding levels of the contract shall be submitted for review and approval by the Tohono O'Odham Legislative Council; and whereas, an amendment has been submitted for review and approval.

Now, Therefore, Be IT Resolved that the Tohono O'Odham Legislative Council does approve this amendment and requests the Bureau of Indian Affairs to carry over any unexpended funds from FY 88 into FY 89 and authorizes expenditures in accordance with the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided, however, that any amendments affecting the funding or funding levels of this contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 3rd. day of May, 1989 at a meeting at which a quorum was present with a vote of 1,471.0 for; -0- against; -0- not voting; and 169.0 (6) absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
