

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Budget Modification to do Archaeological Mitigation
for the Schuk Toak New Development)

RES. NO. 150-89

1 WHEREAS, the Tohono O'Odham Legislative Council convened in a
2 meeting on May 4, 1989 to consider approval of a budget
3 modification to do archaeological mitigation for the
4 Schuk Toak New Development; and

5 WHEREAS, the Development is a part of SAWRSA and that 100% of the
6 costs to do archaeology are the responsibility of the
7 Federal Government; and

8 WHEREAS, mitigation guidelines were approved by the Schuk Toak
9 District in Resolution No. 2-7-89 and the Tohono O'Odham
10 Legislative Council in Resolution No. 86-89; and

11 WHEREAS, the proposed mitigation follows the guidelines set forth
12 in the resolutions; and


13 WHEREAS, the modification, which is attached hereto and made a
14 part thereof, is for \$545,042.30 .

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
16 Legislative Council has reviewed and hereby approves the
17 modification.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
19 that the Tohono O'odham Nation's Officials, to wit: The
20 Chairman, Vice Chairman and any designated official are
21 hereby authorized to negotiate and execute the budget,
22 provided, however, that any amendments affecting the
23 funding or funding levels of this budget shall be
24 submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 4th. day of May, 1989 at a meeting at which a quorum
28 was present with a vote of 1,438.0 for; -0- against; 202.0 not
29 voting; and 03 absent, pursuant to the powers vested in the
30 Council by Section 1 (d)(3) of Article VI of the Constitution
of the Tohono O'odham Nation, adopted by the Tohono O'odham
Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary -Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
