

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Aquatic and Recreation Center Budget)

RES. NO. 151-89

1 WHEREAS, the Aquatic and Recreation Center does provide
2 recreational and educational services to members of the
3 Tohono O'Odham Nation; and

4 WHEREAS, the O'Odham Education Committee feels that this program
5 is an important component of the O'Odham Education
6 Department which enables members of the Tohono O'Odham
7 Nation to keep physically fit as well as mentally (in
8 mind and body); and

9 WHEREAS, the O'Odham Education Committee has approved the Tohono
10 O'Odham Aquatic and Recreation FY '89 budget.

11 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
12 Legislative Council does hereby support and approve the
13 Tohono O'Odham Aquatic and Recreation FY '89 Center
14 Budget commencing May-September 1989.

15 BE IT FURTHER RESOLVED that the Budget & Finance Committee is
16 hereby directed to identify funds to cover the Aquatic
17 and Recreation FY '89 Budget.


18 The foregoing Resolution was passed by the Tohono O'odham Council

the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
