

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Business Lease for Sif Oidak Egg Complex)

RES. NO. 154-89

1 WHEREAS, the Legislative Council has established the Sif-Oidak  
2 Development Authority through Ordinance No. 01-86; and

3 WHEREAS, the Tohono O'Odham Nation has been successful in  
4 obtaining Federal funds from the Community Development  
5 Block Grant (CDBG) Program for the construction of an  
6 Egg Production Complex; and

7 WHEREAS, there has been an area previously identified as the site  
8 for the said Complex; and

9 WHEREAS, the Bureau of Indian Affairs (BIA) requires a business  
10 lease to be executed between the Sif Oidak District and  
11 the Sif Oidak Development Authority.

12 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
13 Legislative Council does hereby approve the Business  
14 Lease between the Sif Oidak District and the Sif Oidak  
15 Development Authority.

16 The foregoing Resolution was passed by the Tohono O'odham Council  
17 on the 5th. day of May, 1989 at a meeting at which a quorum  
18 was present with a vote of 963.0 for; 592.5 against; 84.5 not  
19 voting; and 04 absent, pursuant to the powers vested in the  
20 Council by Section 1(i)(1) of Article VI of the Constitution of  
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
