

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Right-of-Way for providing water to the
Sif Oidak Egg Complex)

RES. NO. 155-89

1 WHEREAS, the Legislative Council has been aware of the
2 development of the Egg Production Complex in the
3 vicinity of the village of North Komelic; and

4 WHEREAS, the Legislative Council is also aware that utilities
5 will have to be provided to the proposed site; and

6 WHEREAS, the Bureau of Indian Affairs, requires consent of land
7 owners for the Right-of-Way.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
9 Legislative Council hereby approves the Right-of-Way for
10 a water line to the Egg Production site.


11 The foregoing Resolution was passed by the Tohono O'odham Council
12 on the 9th day of May, 1989 at a meeting at which a quorum
13 was present with a vote of 963.0 for; 529.5 against; 147.5 not
14 voting; and 04 absent, pursuant to the powers vested in the
15 Council by Section 1 (i)(1) of Article VI of the Constitution of
16 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
17 on January 18, 1986, and approved by the Acting Deputy Assistant
18 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
19 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




