

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Community Health Services 3 Month Extension)

RES. NO. 15-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Community Health Services Program under FY '88 P.L. 93-
3 638 contract with Public Health, Indian Health Services;
4 and

5 WHEREAS, such Tribal operations have been successful and
6 beneficial to the Tohono O'Odham Nation and its people;
7 and

8 WHEREAS, the Tohono O'Odham Nation does desire to extend for
9 provisions of these services during FY 1989; and

10 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
11 approved the Community Health Services Program Budget.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it does authorize and request the Public
14 Health, Indian Health Service to extend the Community
15 Health Services Contract.

16 BE IT FURTHER RESOLVED that the duration of this extension will
17 commence on January 01, 1989 through March 31, 1989.

18 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
19 that the Tohono O'Odham Nation's officials, to wit; the
20 Chairman, Vice Chairman, and any other designated
21 official are hereby authorized to negotiate and execute
22 this contract and any amendments thereto for the
23 duration of the contract, provided however, that any
24 amendments affecting the funding or funding levels of
25 this contract shall be submitted for further prior
26 approval by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 6th. day of January, 1989 at a meeting at which a quorum
29 was present with a vote of 1,582.0 for; -0- against; 58.0 not
30 voting; and 04 absent, pursuant to the powers vested in the
31 Council by Section 1 (f) of Article VI of the Constitution of
32 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
