

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham Behavioral Health Services - Alcoholism/
Rehabilitation and After Care Program for Adolescents Components)

RES. NO. 159-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Behavioral Health Services - Alcoholism and
3 Rehabilitation and After Care for Adolescents Program
4 Components P.L. 99-570 program components extensions of
5 the FY '88 P.L. 93-638 contracts with the Public Health,
6 Indian Health Services; and

7 WHEREAS, any amendments affecting the funding or funding levels
8 of these contracts shall be submitted for review and
9 approval by the Tohono O'Odham Legislative Council; and

10 WHEREAS, the Behavioral Health Services Program - Alcoholism and
11 Rehabilitation and After Care for Adolescents, P.L. 99-
12 570 program components have submitted FY '89 budgets for
13 review and approval.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham
15 Legislative Council does approve these amendments and
16 authorizes expenditures in accordance with the attached
17 budgets.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
19 that the Tohono O'odham Nation's Officials, to wit: the
20 Chairman, Vice Chairman and any designated official are
21 hereby authorized to negotiate and execute the contract,
22 provided, however, that any amendments affecting the
23 funding or funding levels of this contract shall be
24 submitted for further prior approval by this Council.

26 The foregoing Resolution was passed by the Tohono O'odham Council
27 on the 9th. day of May, 1989 at a meeting at which a quorum was
28 present with a vote of 1,317.0 for; 238.0 against; -0- not
29 voting; and 85.0 (7) absent, pursuant to the powers vested in
30 the Council by Section 1 (f) of Article VI of the Constitution
31 of the Tohono O'odham Nation, adopted by the Tohono O'odham
32 Nation on January 18, 1986, and approved by the Acting Deputy
Assistant Secretary -Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
