- WHEREAS, the Demonstration Project has fulfilled its mission to date as documented in reports prepared quarterly.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council supports the renewal of funding for Year Two of the Demonstration Project in the amount of \$275,000.00 for the period between July 1, 1989 June 30, 1990.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that it hereby approves the Demonstration Project Year Two funding budget including the Indirect Cost.
- BE IT FURTHER RESOLVED that the Tohono O'Odham Health Department will quarterly brief the Tohono O'Odham Legislative Council on the status of this Demonstration Project throughout the funding period.
- BE IT FURTHER RESOLVED that the Tohono O'Odham Health Department shall be responsible for project oversight and will provide direction throughout the demonstration period.
- BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: The Chairman, Vice Chairman and any designated official are
