

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Community Health Services FY '89 Budget)

RES. NO. 162-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Community Health Services Program under an extension of  
3 the FY '88 P.L. 93-638 contract with the Public Health,  
4 Indian Health Services; and

5 WHEREAS, any amendments affecting the funding or funding levels  
6 of the contract shall be submitted for review and  
7 approval by the Tohono O'Odham Legislative Council; and

8 WHEREAS, the Community Health Services Program has submitted its  
9 FY '89 Budget for review and approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
11 Legislative Council does approve this amendment and  
12 authorizes expenditures in accordance with the attached  
13 budget.

14 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
15 that the Tohono O'odham Nation's Officials, to wit: The  
16 Chairman, Vice Chairman and any designated official are  
17 hereby authorized to negotiate and execute the contract,  
18 provided, however, that any amendments affecting the  
19 funding or funding levels of this contract shall be  
20 submitted for further prior approval by this Council.

21 The foregoing Resolution was passed by the Tohono O'odham Council  
22 on the 9th. day of May, 1989 at a meeting at which a quorum  
23 was present with a vote of 1,196.5 for; 238.0 against; 120.5  
24 not voting; and 85.0 (5) absent, pursuant to the powers vested  
25 in the Council by Section 1 (f) of Article VI of the  
26 Constitution of the Tohono O'odham Nation, adopted by the Tohono  
27 O'odham Nation on January 18, 1986, and approved by the Acting  
28 Deputy Assistant Secretary -Indian Affairs (Operations) on March  
29 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
