RES. NO. 165-89

- WHEREAS, the Legislative Council of the Tohono O'Odham Nation has been made aware of the projected deficits in contract health services funding for the Tohono O'Odham Nation in the amount of \$946,640.00 likely to occur in FY '89 based upon current rates of expenditures for contract health services; and
- whereas, the Legislative Council of the Tohono O'Odham Nation is aware that current efforts to reduce the rate of contract health services expenses for FY '89 would still result in a projected deficit of \$688,768.00; and
- WHEREAS, the Legislative Council of the Tohono O'Odham Nation recognizes that such deficits and any further action to reduce the deficit contributes acutely to a threat to the health and safety of the O'Odham; and
- WHEREAS, the Legislative Council of the Tohono O'Odham Nation is committed to attain and maintain the highest level of health care services to the O'Odham.
- NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'Odham Nation calls upon the Headquarters of the Indian Health Services to reallocate its resources for FY '89 to ensure that contract health services requirements are funded at a level which in no way jeopardizes the health and services of the O'Odham or precludes them from receiving any service which is not defined as elective or purely discretionary.
- BE IT FURTHER RESOLVED that should the Indian Health Service fail
 to appropriate funding for contract health services for
 the Tohono O'Odham Nation the Congress will be apprised
 of this situation and will be asked to intervene on
 behalf of the Nation with Indian Health Services.
