(Appointment by Acclamation of the Human Resource
Development Committee)

LEGIS. ORDER NO. 194-89

1 WHEREAS, the Tohono O'odham Legislative Council proceeded with
2 the elections of the Human Resource Development
3 Committee in accordance with Section 3 of Article XIII
4 of the Legislative Rules: and

5 WHEREAS, five vacancies were sought to be filled on the Human
6 Resource Development Committee; and

7 WHEREAS, Article XII, Section 3.F.1 of the Legislative Rules
8 provide, "In the event that the number of candidates are
9 equal to or less than the number of vacancies existing,
10 the Legislative Chairperson may request a motion and
11 second from the floor to appoint all the candidates to
12 the vacant positions."; and

13 WHEREAS, there were five candidates for the Human Resource
14 Development Committee.


15 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative



suant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
