

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Appointment by Acclamation of the Legislative Rules Committee)

LEGIS. ORDER NO. 197-89

1 WHEREAS, the Tohono O'odham Legislative Council proceeded with
2 the elections of the Rules Committee in accordance with
3 Section 3 of Article XIII of the Legislative Rules: and

4 WHEREAS, five vacancies were sought to be filled on the
5 Legislative Rules Committee; and

6 WHEREAS, Article XII, Section 3.F.1 of the Legislative Rules
7 provide, "In the event that the number of candidates are
8 equal to or less than the number of vacancies existing,
9 the Legislative Chairperson may request a motion and
10 second from the floor to appoint all the candidates to
11 the vacant positions."; and

12 WHEREAS, there were four candidates for the Legislative Rules
13 Committee.


14 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative

26 not voting; and 01 absent, pursuant to the powers vested in the
27 Council by Section 1 (b) of Article VI of the Constitution of
28 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
29 on January 18, 1986, and approved by the Acting Deputy Assistant
30 Secretary - Indian Affairs (Operations) on March 6, 1986,
31 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
32 984).
