

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Special Counsel on Counsel Contract Amendment with
Richard W. Hughes)

RES. NO. 201-89

1 WHEREAS, the Domestic Affairs Committee met with Mr. Richard W.
2 Hughes on Tuesday, February 21, 1989 to discuss the
3 possibility of retaining him as Counsel on Counsel for
4 the Tohono O'Odham Legislative Council; and

5 WHEREAS, issues and concerns regarding the present system of
6 obtaining Legal Counsel services for the Nation and its
7 members have changed due to the adoption of the new
8 Constitution; and

9 WHEREAS, Mr. Richard W. Hughes presented a proposed contract to
10 serve as Special Counsel on Counsel and a draft Work
11 Plan for the Committee to review and/or make changes;
12 and

13 WHEREAS, after reviewing the documents, the Judiciary and
14 Domestic Affairs Committees, by consensus, approved to
15 retain Mr. Richard W. Hughes to serve as Counsel on
16 Counsel for the Tohono O'Odham Legislative Council; and

17 WHEREAS, the Tohono O'Odham Legislative Council did approve the
18 contract Work Plan and Contract with Richard Hughes, as
19 per Res. No. 88-89; and


20 WHEREAS, on May 10, 1989, a Memorandum was received by the Tohono
21 O'Odham Legislative Branch from the Phoenix Area Office
22 that the Special Counsel Contract with Rothstein,
23 Benett, Dally, Donatelli and Hughes was incomplete,
24 specifically the following provision was not provided
25 with the contract:

26 "The contract shall provide that the payment of all
27 fees and expenses shall be made upon the submission
28 of vouchers for approval by the Assistant Secretary-
29 Indian Affairs or his duly authorized
30 representative." (See IBIA 85-27-A, White Mountain
31 Apache Tribe v. Area Director, Phoenix Area Director,
32 Bureau of Indian Affairs.)

30 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
31 Council that it hereby approves the amendment as
32 required by the Bureau of Indian Affairs Office.


1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 7th day of June, 1989 at a meeting at which a quorum
3 was present with a vote of 1,724.0 for; -0- against; -0- not
4 voting; and -0- absent, pursuant to the powers vested in the
5 Council by Section 2 (a) of Article VI of the Constitution of
6 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
7 on January 18, 1986, and approved by the Acting Deputy Assistant
8 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
9 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

24 submittal.


