

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Administration, Children, Youth and Families)

RES. NO. 203-89

1 WHEREAS, the Tohono O'Odham Nation has operated successfully a
2 Headstart Early Childhood and Day Care Program for its
3 young members; and

4 WHEREAS, the Department of Economic Security through the
5 Administration for Children, Youth and Families provides
6 funds for certain eligible services; and

7 WHEREAS, the Tohono O'Odham Nation is desirous of seeking
8 supplemental funds from the Department of Economic
9 Security to continue operation of its Day Care
10 Programs; and

11 WHEREAS, all of the child-oriented programs have proven
12 beneficial and valuable to the Tohono O'Odham,
13 especially its young members.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
15 Council that it does hereby approve the proposal to the
16 Department of Economic Security, Administration for
17 Children, Youth and Families for funding in the form of
18 reimbursement for the continued operation of the Day
19 Care Services Program.

20 BE IT FURTHER RESOLVED that the duration of this contract will be
21 from July 1, 1989 through June 30, 1992.

22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation's Officials, to wit: the
24 Chairman, Vice Chairman and any designated official are
25 hereby authorized to negotiate and execute the contract,
26 provided, however, that any amendments affecting the
27 funding or funding levels of this contract shall be
28 submitted for further prior approval by this Council.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 7th. day of June, 1989 at a meeting at which a quorum
31 was present with a vote of 1,724.0 for; -0- against; -0- not
32 voting; and -0- absent, pursuant to the powers vested in the
Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
