

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham WIC Program 1990)

RES. NO. 204-89

1 WHEREAS, the Tohono O'Odham Nation has provided preventive health
2 care for women, infants and children during fiscal year
3 89; and

4 WHEREAS, the Inter-Tribal Council of Arizona receives funds from
5 the United States Department of Agriculture for programs
6 designed to benefit women, infants and children; and

7 WHEREAS, the Tohono O'Odham Nation has contracted with the Inter-
8 Tribal Council of Arizona for funds to operate and fund
9 its women, infants and children (WIC) program; and

10 WHEREAS, the services provided to eligible clients has been
11 beneficial and services continue to be necessary to help
12 alleviate nutritional health risks and improve the
13 health of individuals at risk.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Council that
15 it hereby approves the application for funding from the
16 Inter-Tribal Council of Arizona, to continue to operate
17 and provide services to eligible women, infants, and
18 children.


19 BE IT FURTHER RESOLVED that the term of this contract will
20 commence on October 01, 1989 through September 30, 1990
21 unless extended by mutual agreement of both parties.

22 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
23 that the Tohono O'Odham Nation will not fund or operate
24 the program in the interim while negotiations are still
25 being conducted and no executed contract has been
26 awarded by the Inter-Tribal Council of Arizona.

27 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
28 that the Tohono O'Odham Nation's Officials, to wit: the
29 Chairman, Vice Chairman and any designated official are
30 hereby authorized to negotiate and execute the contract,
31 provided, however, that any amendments affecting the
32 funding or funding levels of this contract shall be
submitted for further prior approval by this Council.


The foregoing Resolution was passed by the Tohono O'odham Council on the 7th. day of June, 1989 at a meeting at which a quorum was present with a vote of 1,660.5 for; 63.5 against; -0- not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




