

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Tabling request for Livestock Buying Permit and referring
to Domestic Affairs Committee)

LEGIS. ORDER NO. 206-89

1 WHEREAS, Mr. David Saddler and Mr. Jeff Chalk requested approval
2 of a Livestock Buyer's Permit in the name of A.Z.
3 Livestock Co., from the Tohono O'Odham Legislative
4 Council; and

5 WHEREAS, due to Council's recess and adjournment the permit
6 application did not receive appropriate committee
7 review; and

8 WHEREAS, Mr. Douglas Ramon, Director of the Livestock Department,
9 was not present to report on the background checks of
10 the two applicants; and

11 WHEREAS, the Council would have preferred that Mr. Douglas Ramon
12 be present to answer any concerns that may be raised;
13 and

14 WHEREAS, it would be in the best interest of the Nation if this
15 request be properly reviewed by the Domestic Affairs
16 Committee.


17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
18 Council that it hereby tables action on the Livestock
19 Buyer's permit for A.Z. Livestock Co.

20 BE IT FURTHER RESOLVED that this matter be referred to the
21 Domestic Affairs Committee for review and
22 recommendation.


23 The foregoing Legislative Order was passed by the Tohono O'odham

27 in the Council by Section 1 (a) of Article VI of the
28 Constitution of the Tohono O'odham Nation, adopted by the Tohono
29 O'odham Nation on January 18, 1986, and approved by the Acting
30 Deputy Assistant Secretary - Indian Affairs (Operations) on March
31 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
32 Stat. 984).
