

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Skill Center - P.L. 93-638 Contract)

RES. NO. 210-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the  
2 Skill Center Program for training in construction  
3 trades; and

4 WHEREAS, 25 CFR Part 271.2 requires that all proposals to  
5 recontract under P.L. 93-638 be submitted to the Tohono  
6 O'Odham Legislative Council for approval at least 120  
7 day prior to the contract termination; and

8 WHEREAS, the Tohono O'Odham Legislative Council does desire to  
9 contract for provision of these services during FY 90;  
10 and

11 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and  
12 approved the Tohono O'Odham Skill Center Program  
13 recontract.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
15 Council that it does authorize and request the Bureau of  
16 Indian Affairs to contract with the Tohono O'Odham  
17 Nation under P.L. 93-638 regulations and procedures for  
18 the provision of services titled: Tohono O'Odham Skill  
19 Center.

20 BE IT FURTHER RESOLVED that the term of this contract shall  
21 commence on October 1, 1989 and end September 30, 1990.


22 BE IT FURTHER RESOLVED that the Tohono O'Odham Nation will not  
23 fund or operate programs from which contracts are  
24 requested herewith which have not been negotiated and  
25 executed by the Bureau of Indian Affairs, prior to the  
26 start of the funding year.

27 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
28 that the Tohono O'Odham Nation's Officials, to wit: the  
29 Chairman, Vice Chairman and any designated official are  
30 hereby authorized to negotiate and execute this  
31 contract, provided, however, that any amendments  
32

1 affecting the funding or funding levels of this contract  
2 shall be submitted for further prior approval by this  
3 Council.


4 The foregoing Resolution was passed by the Tohono O'odham Council  
5 on the 8th day of June, 1989 at a meeting at which a quorum  
6 was present with a vote of 1,724.0 for; -0- against; -0- not  
7 voting; and -0- absent, pursuant to the powers vested in the  
8 Council by Section 1 (f) of Article VI of the Constitution of  
9 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
10 on January 18, 1986, and approved by the Acting Deputy Assistant  
11 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant  
12 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
