LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL (Referring Proposed Ordinance, "Defining the Powers, Duties, and Authority of the Office of Independent Counsel" to the Districts)

LEGIS. ORDER 211-89

WHEREAS, Ordinance No. 02-89, "Defining the Powers, Duties, and Authority of the Office of Independent Counsel" was vetoed by the Chairman of the Nation and failed an override attempt by the Legislature; and

WHEREAS, an amended ordinance titled, "Defining the Powers,
Duties, and Authority of the Office of Independent
Counsel," which addressed the veto concerns of the
Chairman of the Nation, was proposed for Council
reconsideration; and

whereas, before action on this ordinance is taken, the Membership of the Tohono O'odham Nation should be given an opportunity to review and comment on said proposed ordinance.

NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative

Council that the amended proposed ordinance titled,

"Defining the Powers, Duties, and Authority of the

Office of Independent Counsel" is hereby tabled and

referred to the respective Districts of the Tohono

O'odham Nation for review and recommendation.

BE IT FURTHER RESOLVED that the recommendations of the Nation's

Districts concerning the proposed ordinance titled,

"Defining the Powers, Duties, and Authority of the

Office of Independent Counsel" be return to the next
session of the Legislative Council.

The foregoing Legislative Order was passed by the Tohono O'odham Council on the 9th. day of June, 1989 at a meeting at which a quorum was present with a vote of 447.5 for; 1,157.0 against; 119.5 not voting; and 01 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
