LEGIS. ORDER 212-89

- WHEREAS, Ordinance No. <u>02-89</u>, "Defining the Powers, Duties, and Authority of the Office of Independent Counsel" was vetoed by the Chairman of the Nation and failed an override attempt by the Legislature; and
- WHEREAS, an amended ordinance titled, "Defining the Powers,

  Duties, and Authority of the Office of Independent

  Counsel," which addressed the veto concerns of the

  Chairman of the Nation, was proposed for Council

  reconsideration; and
- WHEREAS, this amended ordinance was not reviewed by any of the newly appointed Legislative Committees; and
- WHEREAS, a committee review by the Judiciary Committee was requested before formal action by this Council is taken.
- NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative

  Council that the amended ordinance titled, "Defining
  the Powers, Duties, and Authority of the Office of
  Independent Counsel" is hereby tabled and referred to
  the Legislative Judiciary Committee for review and
  recommendation.
- BE IT FURTHER RESOLVED that the Judiciary Committee return their recommendations concerning this topic to the next session of the Legislative Council.

The foregoing Legislative Order was passed by the Tohono O'odham Council on the 9th. day of June, 1989 at a meeting at which a quorum was present with a vote of 1,352.0 for; 289.0 against; 83.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
