- WHEREAS, the Tohono O'Odham Legislative Council is desirous to continue to protect and ensure the well-being of adolescents, pregnant adolescent, adolescent parents, their children and families; and
- WHEREAS, it is the intent of the Tohono O'Odham Legislative

 Council to better integrate and coordinate existing

 health care resources available to adolescents.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

 Council that it hereby approves the third year funding

 for the Adolescent Family Life Demonstration Project

 Grant.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed grant has been awarded by the Office of Adolescent Pregnancy Program.
- BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided, however, that any amendments affecting the funding or funding levels of this grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 9th. day of June, 1989 at a meeting at which a quorum was present with a vote of 1,495.5 for; 114.5 against; 114.0 not voting; and -0- absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
