

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adolescent Family Life Demonstration Project Grant)

RES. NO. 213-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Adolescent Family Life Demonstration Program under a
3 three (3) year grant with the Office of Adolescent
4 Pregnancy Program; and

5 WHEREAS, the Tohono O'Odham Legislative Council is desirous to
6 continue to protect and ensure the well-being of
7 adolescents, pregnant adolescent, adolescent parents,
8 their children and families; and

9 WHEREAS, it is the intent of the Tohono O'Odham Legislative
10 Council to better integrate and coordinate existing
11 health care resources available to adolescents.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it hereby approves the third year funding
14 for the Adolescent Family Life Demonstration Project
15 Grant.

16 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
17 that the Tohono O'Odham Nation will not fund or operate
18 the program in the interim while negotiations are still
19 being conducted and no executed grant has been awarded
20 by the Office of Adolescent Pregnancy Program.

21 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
22 that the Tohono O'odham Nation's Officials, to wit: the
23 Chairman, Vice Chairman and any designated official are
24 hereby authorized to negotiate and execute the grant,
25 provided, however, that any amendments affecting the
26 funding or funding levels of this grant shall be
27 submitted for further prior approval by this Council.

28 The foregoing Resolution was passed by the Tohono O'odham Council
29 on the 9th. day of June, 1989 at a meeting at which a quorum
30 was present with a vote of 1,495.5 for; 114.5 against; 114.0
31 not voting; and -0- absent, pursuant to the powers vested in the
32 Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
