

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA PY '1989)

RES. NO. 216-89

1 WHEREAS, the Job Training Partnership Act was enacted into law in
2 1982 replacing the Comprehensive Employment Training Act
3 (CETA); and

4 WHEREAS, funding is made available to State and Tribal
5 Governments to establish programs for improving the
6 employment prospects of eligible persons through the
7 designation of service delivery areas; and

8 WHEREAS, the State of Arizona is entitled to JTPA funds to
9 develop a network of employment training programs
10 throughout the State; and

11 WHEREAS, the Indian Reservations in Arizona have been designated
12 as service delivery areas and are eligible to receive
13 State JTPA funds.


14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
15 Council that it hereby approves the attached budget in
16 the amount of \$229,177.00

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation will not fund or operate
19 the program in the interim while negotiations are still
20 being conducted and no executed Contract has been
21 awarded by the Department of Economic Security.

22 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
23 that the Tohono O'odham Nation's Officials, to wit: the
24 Chairman, Vice Chairman and any designated official are
25 hereby authorized to negotiate and execute the contract,
26 provided, however, that any amendments affecting the
27 funding or funding levels of this contract shall be
28 submitted for further prior approval by this Council.


29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 16th. day of June, 1989 at a meeting at which a quorum
31 was present with a vote of 1,724.0 for; -0- against; -0- not
32 voting; and 01 absent, pursuant to the powers vested in the
Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




