

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JTPA Title II-A Budget Amendment)

RES. NO. 218-89

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 JTPA Title II-A Program under the PY '88 Contract with
3 the State of Arizona; and

4 WHEREAS, any amendments affecting the funding or funding levels
5 of the contract shall be submitted for review and
6 approval by the Tohono O'odham Legislative Council; and

7 WHEREAS, an amendment has been submitted for review and approval
8 by the JTPA Title II-A Program; and


9 WHEREAS, the original plan budget was \$273,357.00 with the
10 variance of \$4,153.00 (6%) making a final total budget
11 of \$277,510.00.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that it hereby approves the amendment to the
14 JTPA Title II-A Program.

15 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
16 that the Tohono O'odham Nation's Officials, to wit: the
17 Chairman, Vice Chairman and any designated official are
18 hereby authorized to negotiate and execute the contract,
19 provided, however, that any amendments affecting the
20 funding or funding levels of this contract shall be
21 submitted for further prior approval by this Council.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 16th. day of June, 1989 at a meeting at which a quorum
24 was present with a vote of 1,724.0 for; -0- against; -0- not
25 voting; and 01 absent, pursuant to the powers vested in the
26 Council by Section 1 (f) of Article VI of the Constitution of
27 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
28 on January 18, 1986, and approved by the Acting Deputy Assistant
29 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
30 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
