

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL
(Adoption of the Legislative Calendar
June 01, 1989 - May 31, 1990)

LEGIS. ORDER NO. 221-89

1 WHEREAS, the Legislative Rules and Policies states in Article I,
2 Section 1.A:

3 "Prior to an official adjournment, the Legislative
4 Council shall adopt a Legislative Calendar which
5 shall commence on the first working day of June on
6 which the Legislative Council will be called into
7 legislative session. The Calendar shall specify
8 dates for the general sessions, recess periods,
9 recognized holidays and the days of adjournment" and
10 Section 1.A.3:


11 "The Legislative Calendar shall be based only on
12 working days and scheduled paid holidays"; and

13 WHEREAS, the Rules Committee of the Legislative Council had
14 prepared a Legislative Calendar in accordance with the
15 Legislative Rules and Policies.


16 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does
17 hereby adopt the Legislative Council Calendar which
18 commences June 1, 1989 and ends May 31, 1990.

19 The foregoing Legislative Order was passed by the Tohono O'odham
20 Council on the 16th. day of June, 1989 at a meeting at which a
21 quorum was present with a vote of 1,434.0 for; 290.0 against; -
22 -0- not voting; and 02 absent, pursuant to the powers vested in
23 the Council by Section 1(a) of Article VI of the Constitution
24 of the Tohono O'odham Nation, adopted by the Tohono O'odham
25 Nation on January 18, 1986, and approved by the Acting Deputy
26 Assistant Secretary -Indian Affairs (Operations) on March 6,
27 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
28 Stat. 984).
