WHEREAS, the ordinance prescribed the powers, duties and authorities of the office of independent counsel and therefore would properly fall under the jurisdiction of the Legislative Domestic Affairs Committee; and

WHEREAS, a review was requested by the Judiciary Committee; and .

WHEREAS, the use of legal counsel is subject to jurisdictional oversight of the Domestic Affairs Committee; and

WHEREAS, the Legislative Council erred in referring the matter to the Judiciary Committee and does hereby direct the Domestic Affairs Committee to assume its proper jurisdiction over the matter.

NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative

Council that it hereby rescinds Legislative Order No.

212-89, "Tabling proposed ordinance, Defining the

Powers, Duties, and Authority of the Office of
Independent Counsel'."

BE IT FURTHER RESOLVED that the issue of the Independent Counsel is hereby referred to the Domestic Affairs Committee.

The foregoing Legislative Order was DEFEATED by the Tohono O'odham Council on the 16th. day of June , 1989 at a meeting at which a quorum was present with a vote of 490.5 for; 951.0 against; 282.5 not voting; and 03 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
