- WHEREAS, an update report from the Judiciary Committee was requested and included on the agenda for June 16, 1989 Special Council meeting; and
- WHEREAS, the Judiciary Committee as part of their update stated a new draft concerning the Independent Counsel was submitted by Richard Hughes, Special Counsel on Counsel Project for the Domestic Affairs Committee; and
- WHEREAS, the Judiciary Committee was not prepared to make a recommendation on the draft; and
- WHEREAS, concerns were expressed on the use of Richard Hughes' services in preparing the draft stating the possibility that it does not fall under his scope of work; and
- WHEREAS, concerns were expressed on defining the Powers, Duties, and Authority of the Office of Independent Counsel in an expedient manner.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby approves scheduling a Special Meeting on Friday, June 23, 1989.
- BE IT FURTHER RESOLVED that the Judiciary Committee will report on the proposed Ordinance defining the Powers, Duties, and Authority of the Office of Independent Counsel.
- BE IT FURTHER RESOLVED that the Domestic Affairs Committee present a report on the use of Mr. Richard Hughes' services in redrafting the proposed ordinance regarding the Independent Counsel.

The foregoing Legislative Order was DEFEATED by the Tohono O'odham Council on the 16th. day of June, 1989 at a meeting at which a quorum was present with a vote of 690.0 for; 951.0 against; 83.0 not voting; and 02 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
