

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Pisinemo District Six Month Budget FY 1990)

RES. NO. 227-89

1 WHEREAS, the District Council of the Pisinemo District did on
2 June 24, 1989 by District Resolution No. 2-89, approved
3 their six (6) month District Budget in the amount of
4 Fifty Three Thousand, Three Hundred Twenty Three Dollars
5 and No Cents (\$53,323.00); and

6 WHEREAS, the Pisinemo District has sufficient funds in their
7 District Account on deposit with the Tohono O'Odham
8 Accounting Department to cover their proposed budget;
9 and

10 WHEREAS, the Tohono O'Odham Legislative Council has reviewed the
11 Pisinemo District budget which is attached and finds it
12 in order.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
14 Council that it hereby approves the Pisinemo District
15 six (6) month budget as presented in the amount of Fifty
16 Three Thousand, Three Hundred Twenty Three Dollars and
17 No Cents (\$53,323.00) and authorizes expenditures in
18 accordance therewith.

19 The foregoing Resolution was passed by the Tohono O'Odham Council
20 on the 10th day of July, 1989 at a meeting at which a quorum
21 was present with a vote of 1,724.0 for; -0- against; -0- not
22 voting; and -0- absent, pursuant to the powers vested in the
23 Council by Section 1 (d)(3) of Article VI of the Constitution of
24 the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation
25 on January 18, 1986, and approved by the Acting Deputy Assistant
26 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
27 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




