

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Sif-Oidak District FY 1989-90 Budget)

RES. NO. 228-89

1 WHEREAS, the Sif Oidak District Council has reviewed and approved  
2 their projected expenditures to meet its goals and  
3 objectives for the fiscal year 1989-90; and

4 WHEREAS, the Sif Oidak District Council has sufficient funds  
5 within their IIM Account to meet their projections for  
6 FY 1989-90.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
8 Council that it does hereby approve the Sif Oidak  
9 District budget in the amount of \$155,524.91 for FY  
10 1989-90.

11 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative  
12 Council authorizes the Sif Oidak District to continue  
13 maintaining a separate checking and/or savings account  
14 with the First Interstate Bank of Arizona in Casa  
15 Grande, which shall provide that any of the following  
16 Officers of the District Council, Chairperson, Vice-  
17 Chairperson or the Secretary and/or one Council  
18 Representative to be the signers.

19 BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative  
20 Council authorizes the Sif Oidak District to transfer  
21 from the funds on deposit in the District's IIM Account  
22 and into aforementioned accounts with the First  
23 Interstate Bank, the sum of \$77,762.45 being one-half  
24 of the amount of the District's fiscal year 1989-90  
25 budget, the remaining sum of \$77,762.45 for the said  
26 budget period will be transferred as needed.

27 The foregoing Resolution was passed by the Tohono O'odham Council  
28 on the 10th. day of July, 1989 at a meeting at which a quorum  
29 was present with a vote of 1,667.0 for; -0- against; 57.0 not  
30 voting; and -0- absent, pursuant to the powers vested in the  
31 Council by Section 1 (d)(3) of Article VI of the Constitution of  
32 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
on January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
