

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL  
(Council to Temporarily Recess)

LEGIS. ORDER NO. 234-89

1 WHEREAS, on July 11, 1989 the Tohono O'odham Judiciary scheduled  
2 a preliminary hearing in the case brought by the  
3 Nation's Chairman against eight individuals; and

4 WHEREAS, O'odham in Mexico items were scheduled as agenda item #5  
5 to be entertained on this day because the program was  
6 scheduled to be on travel status the rest of the week;  
7 and

8 WHEREAS, Members of the Council were interested in the case  
9 pending at the Judiciary; and

10 WHEREAS, the issues concerning the O'odham in Mexico required  
11 Council consideration on this day.

12 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative  
13 Council that it hereby recesses in order to allow those  
14 Members of the Council interested in the pending case to  
15 attend the hearing.


16 BE IT FURTHER RESOLVED that the Tohono O'odham Council will  
17 address the O'odham in Mexico issues upon their return  
18 from the hearing.

19 The foregoing Legislative Order was passed by the Tohono O'odham  
20 Council on the 11th. day of July, 1989 at a meeting at which a  
21 quorum was present with a vote of 907.5 for; 387.0 against; 429.5  
22 not voting; and 03 absent, pursuant to the powers vested in the  
23 Council by Section 1 (a) of Article VI of the Constitution of  
24 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation  
25 on January 18, 1986, and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986,  
27 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.  
28 984).
