- WHEREAS, the Tohono O'odham Legislative Council convened in a meeting on January 26, 1989 to consider approval of the stockpiling of excess material from the C.A.P. regulating reservoir for use on the San Xavier New Farm Development; and
- WHEREAS, the Tohono O'odham Legislative Council does not want the U.S. Bureau of Reclamation to remove any excess material excavated from the reservoir site from Nation land; and
- WHEREAS, the Legislative Council realizes that there may not be any excess material excavated from the reservoir site from Nation land; and
- WHEREAS, the Legislative Council realizes that there may not be any excess material, it also realizes that there may be up to 50,000 cubic yards of material; and
- WHEREAS, the Legislative Council believes that it would be in the best interest of the Nation to stockpile any excess material in the southwest portion of Sector 2, as shown on the attached figure.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves of the stockpiling of excess material from the C.A.P. reservoir in the southeast portion of Sector 2 of the San Xavier New Farm Development.

The foregoing Resolution was passed by the Tohono O'odham Council on the <u>26th.</u> day of <u>January</u>, <u>1989</u> at a meeting at which a quorum was present with a vote of 1,093.0 for; <u>63.0</u> against; <u>326.0</u> not voting; and 158.0 (03) absent, pursuant to the powers vested in the Council by Section 1 i (2) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, Stat. 984).
