

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Stockpiling of Excess Material from the C.A.P.
Reservoir for use on the San Xavier New Farm Development)

RES. NO. 23-89

1 WHEREAS, the Tohono O'odham Legislative Council convened in a
2 meeting on January 26, 1989 to consider approval of the
3 stockpiling of excess material from the C.A.P. regula-
4 ting reservoir for use on the San Xavier New Farm
5 Development; and

6 WHEREAS, the Tohono O'odham Legislative Council does not want the
7 U.S. Bureau of Reclamation to remove any excess material
8 excavated from the reservoir site from Nation land; and

9 WHEREAS, the Legislative Council realizes that there may not be
10 any excess material excavated from the reservoir site
11 from Nation land; and

12 WHEREAS, the Legislative Council realizes that there may not be
13 any excess material, it also realizes that there may be
14 up to 50,000 cubic yards of material; and

15 WHEREAS, the Legislative Council believes that it would be in the
16 best interest of the Nation to stockpile any excess
17 material in the southwest portion of Sector 2, as shown
18 on the attached figure.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legis-
20 lative Council hereby approves of the stockpiling of
21 excess material from the C.A.P. reservoir in the south-
22 east portion of Sector 2 of the San Xavier New Farm
23 Development.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 26th. day of January, 1989 at a meeting at which a quorum
26 was present with a vote of 1,093.0 for; 63.0 against; 326.0
27 not voting; and 158.0 (03) absent, pursuant to the powers vested
28 in the Council by Section 1 i (2) of Article VI of the Consti-
29 tution of the Tohono O'odham Nation, adopted by the Tohono
30 O'odham Nation on January 18, 1986, and approved by the Acting
31 Deputy Assistant Secretary - Indian Affairs (Operations) on March
32 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
