

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Pre-Application for EPA Grant Indian Set Aside Funds)

RES. NO. 242-89

1 WHEREAS, the Environmental Protection Agency (EPA) has set aside
2 funds, under an amendment to the 1987 Clean Water Act to
3 help pay for planning, design and building of wastewater
4 treatment systems to serve Indian Tribes and Alaska
5 Native Peoples; and

6 WHEREAS, the Tohono O'Odham Nation has critical unmet needs, in
7 the are of wastewater treatment systems, projected to
8 cost several millions of dollars; and

9 WHEREAS, projects which would address this unmet need are prime
10 candidates for funding under the EPA Indian set aside
11 grant program; and

12 WHEREAS, the Indian Health Service, Office of Environmental
13 Health, in concert with the Nation's Research and
14 Planning Department has conducted an engineering
15 analysis of proposed projects which represent the most
16 critical need of the Nation and which have the highest
17 potential for success under EPA guidelines; and

18 WHEREAS, those needs identified, by this process, and their
19 priority ranking are:

- 20 1. Sells Lagoon Rehabilitation & Expansion
- 21 2. Scattered Projects (Septic Tank/Leach Field)
- 22 3. Chui Chu Collection and Treatment System
- 23 4. Santa Rosa Village Community Treatment Facility
- 24 5. Pisinemo Community Treatment Facility
- 25 6. Queen's Well Community Collection and Treatment
Facility

26 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham
27 Legislative Council hereby approves and authorizes the
28 submission of pre-applications to the EPA for the
29 above-stated wastewater treatment proposals.

30 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
31 that the Tohono O'odham Nation's Officials, to wit: the
32 Chairman, Vice Chairman and any designated official are

hereby authorized to negotiate and execute the grant,
provided, however, that any amendments affecting the
funding or funding levels of this grant shall be
submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council
on the 13th. day of July, 1989 at a meeting at which a quorum
was present with a vote of 1,667.0 for; 57.0 against; -0- not
voting; and -0- absent, pursuant to the powers vested in the
Council by Section 1 (f) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
