- WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'Odham Nation and its people;
- WHEREAS, the Tohono O'Odham Nation does desire to extend the contract for provision of services during FY 1990; and
- WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the FY 1990 Social Services contract extension and budget.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does authorize and request the Bureau of Indian Affairs to extend Contract No. H50C14209071 with the Tohono O'Odham Nation under P.L. 93-638 regulations and procedures for the provision of services titled: Social Services.
- BE IT FURTHER RESOLVED that the duration of this contract extension will commence on October 01, 1989 through September 30, 1990.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract extension has been approved by the Bureau of Indian Affairs.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.
