

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'Odham FY '90 Adult Care Group Home
Contract Extension)

RES. NO. 244-89

1 WHEREAS, the Tohono O'Odham Nation is presently operating the
2 Adult Care Group Home Program under an FY 1989 P.L. 93-
3 638 contract with the Bureau of Indian Affairs; and
4 WHEREAS, such tribal operations have been successful and
5 beneficial to the Tohono O'Odham Nation and its people;
6 and
7 WHEREAS, the Tohono O'Odham Nation does desire to extend the
8 contract for provision of services during FY 1990; and
9 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
10 approved the FY 1990 Adult Care Group Home contract
11 extension and budget.
12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it does authorize and request the Bureau of
14 Indian Affairs to extend Contract No. H50C14209070 with
15 the Tohono O'Odham Nation under P.L. 93-638 regulations
16 and procedures for the provision of services titled:
17 Adult Care Group Home
18 BE IT FURTHER RESOLVED that the duration of this contract
19 extension will commence on October 01, 1989 through
20 September 30, 1990.
21 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
22 that the Tohono O'Odham Nation will not fund or operate
23 the program in the interim while negotiations are still
24 being conducted and no executed contract extension has
25 been approved by the Bureau of Indian Affairs.
26 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council
27 that the Tohono O'Odham Nation's Officials, to wit: the
28 Chairman, Vice Chairman and any designated official are
29 hereby authorized to negotiate and execute the contract,
30 provided however, that any amendments affecting the
31 funding or funding levels of the contract shall be
32 submitted for further prior approval by this Council.

1 The foregoing Resolution was passed by the Tohono O'odham Council
2 on the 13th. day of July, 1989 at a meeting at which a quorum
3 was present with a vote of 1,724.0 for; -0- against; -0- not
4 voting; and -0- absent, pursuant to the powers vested in the
5 Council by Section 1 (f) of Article VI of the Constitution of
6 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
7 on January 18, 1986, and approved by the Acting Deputy Assistant
8 Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant
9 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
