NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative 12 Council that it does authorize and request the Bureau of Indian Affairs to extend Contract No. H50C14209074 with the Tohono O'Odham Nation under P.L. 93-638 regulations and procedures for the provision of services titled: 16 Agriculture Extension. BE FURTHER RESOLVED that the duration of this contract IT 18 extension will commence on October 01, 1989 through 19 September 30, 1990. BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate 22 the program in the interim while negotiations are still 23 being conducted and no executed contract extension has 24 been approved by the Bureau of Indian Affairs. BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council 26 that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are 28 hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the 30 funding or funding levels of the contract shall be submitted for further prior approval by this Council. 32
