WHEREAS, the Elderly Program desires to seek continued funding by submitting a proposal to the Office of Human Development Services, Administration on Aging; and

WHEREAS, the Elderly proposal will benefit elder members of the Tohono O'odham Nation by providing for their nutritional and social support services.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative

Council that it does hereby approve the proposal for

continued funding of the Elderly Program to provide

services to eligible members of the Tohono O'odham

Nation.

BE IT FURTHER RESOLVED that the term of this Grant shall Commence on April 01, 1989 and end on March 31, 1990.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice-Chairman and any designated official are hereby authorized to negotiate and execute this Grant, provided however, that any amendments affecting the funding or funding levels of this Grant shall be submitted for further prior approval by this Council.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the indirect cost be waived for the Elderly Program Title VI Grant.

The foregoing Resolution was passed by the Tohono O'odham Council on the <u>26th</u>. day of <u>January</u>, <u>1989</u> at a meeting at which a quorum was present with a vote of <u>1,392.0</u> for; <u>-0-</u> against; <u>248.0</u> not voting; and <u>02</u> absent, pursuant to the powers vested in the Council by <u>Section 1 (f)</u> of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
