- WHEREAS, the Tohono O'Odham Legislative Council has reviewed and approved the FY 1990 Law Enforcement contract extension and budget.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
 Council that it does authorize and request the Bureau of
 Indian Affairs to extend Contract No. H50C14209067 with
 the Tohono O'Odham Nation under P.L. 93-638 regulations
 and procedures for the provision of services titled:
 Law Enforcement.
- BE IT FURTHER RESOLVED that the duration of this contract extension will commence on October 01, 1989 through September 30, 1990.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed contract extension has been approved by the Bureau of Indian Affairs.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.
