

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Head Start Program FY '90 Grant)

RES. NO. 255-89

1 WHEREAS, the Tohono O'Odham Nation has recognized the importance  
2 of Head Start Education and Stimulation; and

3 WHEREAS, the Tohono O'Odham Nation has operated a Head Start  
4 Program to provide and serve educational and pre-school  
5 learning experiences for children between the ages of 3-  
6 5 years; and

7 WHEREAS, the Department of Health & Human Services,  
8 Administration for Children, Youth & Families, has  
9 provided funding for the operation of the Head Start  
10 Program; and

11 WHEREAS, the Administration for Children, Youth and Families will  
12 provide funds for the continued operation of the Head  
13 Start Program to eligible and qualifying applicants; and

14 WHEREAS, the Head Start Program has prepared a proposal for FY  
15 '90 program operations to be submitted to the Department  
16 of Health & Human Services; and

17 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and  
18 approved the Head Start grant.

19 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
20 Council that it does authorize and request the  
21 Department of Health & Human Services to contract with  
22 the Tohono O'Odham Nation for the provision of services  
23 titled: Head Start Program.

24 BE IT FURTHER RESOLVED that the duration of this grant will be  
25 from November 01, 1989 through October 31, 1990.

26 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
27 that the Tohono O'Odham Nation will not fund or operate  
28 the program from which grants are requested herewith  
29 which have not been negotiated and executed by the  
30 Department of Health & Human Services prior to the start  
31 of the funding year.

32 BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council  
that the Tohono O'Odham Nation's Officials, to wit: the

Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 14th day of July, 1989 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; and 07 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
