- WHEREAS, the Tohono O'Odham Legislative Council is desirous to continue to provide Vocational and Education Training Program to Native Americans; and
- WHEREAS, the Tohono O'Odham Skill Center has submitted a budget for Fiscal Year 1990 for review and approval by the Tohono O'Odham Legislative Council.
- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative

 Council that it does hereby approve the third year

 request for funding for the Tohono O'Odham Skill Center

 to provide a Vocational Indian Education Program for

 Native Americans.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation will not fund or operate the program in the interim while negotiations are still being conducted and no executed grant has been awarded by the Office of U.S. Department of Education, Office of Vocational and Adult Education.
- BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract, provided however, that any amendments affecting the funding or funding levels of the contract shall be submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 14th. day of July, 1989 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; and 07 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
