(Approving Privilege Tax and TERO Fee Deferred Payment - Sif
Oidak District Egg Production Project)

1 WHEREAS, the Tohono O'odham Nation has encouraged and supported
2 the development and/or improvement of Economics for the
3 Nation and its eleven districts; and

4 WHEREAS, the Tohono O'odham Legislative Council is aware and have
5 supported the Sif Oidak District Egg Production Project;
6 and


7 WHEREAS, the Sif Oidak District has been successful in obtaining
8 approval and funding from the Community Development
9 Block Grant (CDBG), including funds that had to be
10 supplemented by the District's IIM Account (i.e., Cash
11 Contribution and Bank Loan).

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that it does hereby approve the request to defer
14 the payment of the Privilege Tax and TERO Fee for the
15 Sif Oidak District Egg Project.

16 BE IT FURTHER RESOLVED that the payment is deferred to December
17 31, 1989, the first payment is due and payable on
18 January 01, 1990 and thereafter on a quarterly basis.


19 The foregoing Resolution was passed by the Tohono O'odham Council

22 not voting; and 02 absent, pursuant to the powers vested in the
23 Council by Section 1 d (4) of Article VI of the Constitution of
24 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
25 on January 18, 1986, and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986,
27 pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
28 984).
