RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Tohono O'odham Psychological Services Legal Budget [Mod.#1])

RES. NO. 267-89

- WHEREAS, the Legislative Council of the Tohono O'odham Nation did by Resolution No. 356-88 appropriate the use of \$63,000 of the General Fund to support the legal fees and miscellaneous expenses related to the appeal on the record; and
- WHEREAS, the Tohono O'Odham Nation requested a Hearing protesting the Indian Health Service's August 12, 1988 decision to rescind the Tohono O'Odham Psychological Services (TOPS) contract; and
- WHEREAS, the Administrative Law Judge of the Department of Health and Human Services Departmental Appeals Board has concluded and has submitted a recommended decision in this case (Docket No. C-84 of 30 June 1989), ruling that the Indian Health Service "... improperly rescinded the psychological service component of its behavioral health services contract with Appellant" (Nation); and
- WHEREAS, the Tohono O'Odham Legislative Council does hereby accept the decision of the Appeals Board to be final; and
- WHEREAS, the Nation does retain the services of HOBBS, STRAUS,

 DEAN and WILDER in its appeal of the IHS' declination of
 the fiscal year 1988-89 Tohono O'odham Psychological
 Services Program.
- NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby authorize the existing Tohono O'odham Psychological Services Legal budget to be modified to appropriate additional funds in the amount not to exceed \$132,106.61.
- BE IT FURTHER RESOLVED that the funds appropriated shall only be expended in accordance with the attached revised budget, additional expenditures shall not be incurred without prior approval or appropriations by this Council.

BE IT FURTHER RESOLVED that the Chairman and Vice Chairman of the Legislative Health and Human Services Committee (Alex Ramon and Percy Lopez), the Chairwoman of the Health Board (Sharmain Garcia), Director of the Tohono O'odham Health Department (Ed Hansen), Representatives of the Grants and Contracts Office (Ora Campillo and Luke Abrams), Chairman of the Legislative Council (Edward D. Manuel) and Chairman of the Tohono O'Odham Nation (Angelo Joaquin, Sr.) or their delegates, are hereby authorized to represent the Nation, with Legal Counsel, to begin deliberations towards a favorable conclusion in the Nation's appeal. The authority of this delegation shall be limited so that all final decisions in behalf of the Nation will be acted on by the Legislative Council. In any case, the delegation is to report to the Legislative Council at its September 1989 General Session.

The foregoing Resolution was passed by the Tohono O'odham Council on the 19th. day of July , 1989 at a meeting at which a quorum was present with a vote of 1,564.5 for; 53.5 against; -0- not voting; and 106.0 (05) absent, pursuant to the powers vested in the Council by Section 1 (b) & (d) (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
