

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY '89 Budget for Vi-ikam Doag Industries Sheet
Metal Division)

RES. NO. 26-89

1 WHEREAS, Vi-ikam Doag Industries was chartered as a non-profit
2 public corporation to develop business and employment
3 opportunities in and for the San Lucy District; and

4 WHEREAS, the Board of Directors of Vi-ikam Doag Industries has
5 submitted an operating budget for FY 1989 in the sum of
6 \$370,171.00 to support its activities on behalf of the
7 San Lucy District; and

8 WHEREAS, the San Lucy District Council has reviewed and approves
9 of the activities and expenditures proposed in the
10 submitted budget.


11 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council
12 release the amount of \$370,171.00 from P.L. 99-503 Funds
13 activities to support in accordance with Schedule A.

14 BE IT FURTHER RESOLVED that the release of monies will occur only
15 after the Management Agreement (Schedule B) has been
16 executed between Vi-ikam Doag Industries and the
17 General Manager.

18 BE IT FURTHER RESOLVED that quarterly financial reports for the
19 Sheet Metal Division of the Vi-ikam Doag Industries be
20 submitted to the Tohono O'odham Nation's Accounting
21 Department, the Commerce Committee and the Tohono
22 O'odham Legislative Council.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 26th day of January, 1989 at a meeting at which a quorum
25 was present with a vote of 1,343.5 for; 63.0 against; 233.5
26 not voting; and 02 absent, pursuant to the powers vested in the
27 Council by Section 1 (f) of Article VI of the Constitution of
28 the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
on January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986,
pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.
984).
