WHEREAS, the Tohono O'odham Nation has submitted an application for a grant to fund certain eligible Indian Community Development Block Grant Program activities and in connection with such application resolve and made certain assurances.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative council that prior to the submission of its application, the governing body of the Tohono O'odham Nation has provided tribal citizens through their Council Representatives, especially those living in areas where activities are proposed or ongoing, with adequate information concerning the amount of funds available for proposed community development and housing activities, the range of activities that may be assisted, and other important program requirements, and solicited their views and participation.

BE IT FURTHER RESOLVED that traditional Tribal means of citizen involvement were followed through District Council meetings and Tohono O'odham Legislative Council meetings, and opportunity was given to articulate needs, express preferences about proposed community development and housing activities, assist in the selection of district priorities, and otherwise participate in the development of the application.

BE IT FURTHER RESOLVED that any comments or views expressed by Tribal Members were considered and have modified the application accordingly.

BE IT FURTHER RESOLVED that the modified application has been made available to Tribal Members for review and comment.

The foregoing Resolution was passed by the Tohono O'odham Council on the $\underline{14th}$ day of \underline{August} , $\underline{1989}$ at a meeting at which a quorum was present with a vote of $\underline{1,491.0}$ for; $\underline{59.5}$ against; $\underline{173.5}$ not voting; $\underline{03}$ absent, pursuant to the powers vested in the Council by Section $\underline{1}$ (c)(2) & (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
