(Tohono O'odham Food Distribution & Family Nutrition
Services Budget Request)

RES. NO. 285-89

1 WHEREAS, the Tohono O'odham Nation has operated successfully a
2 Program whereby the diet and nutritional needs of
3 eligible Tohono O'odham people have been served by
4 supplementing other federal social services programs;
5 and

6 WHEREAS, the funding for the Tohono O'odham Food Distribution/
7 Family Nutrition Services has been provided through the
8 United States Department of Agriculture; and


9 WHEREAS, an on site review was conducted of the Food Distribution
10 Program and major discrepancies were identified; and

11 WHEREAS, the funding agency has stressed to the Nation that
12 failure to bring the warehouse and the administration of
13 the Food Distribution Program into compliance with
14 federal regulation could result in the withholding of
15 federal funds and the suspension of food shipments to
16 the Tohono O'odham Food Distribution Program.


17 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
18 Council that it hereby approves the attached budget to
19 resolve the discrepancies identified by the funding
20 agency.

21 The foregoing Resolution was passed by the Tohono O'odham Council
22 on the 17th day of August, 1989 at a meeting at which a quorum
23 was present with a vote of 1,724.0 for; -0- against; -0- not
24 voting; 04 absent, pursuant to the powers vested in the Council
by Section 1 (d) of Article VI of the Constitution of the Tohono
25 O'odham Nation, adopted by the Tohono O'odham Nation on January
18, 1986, and approved by the Acting Deputy Assistant Secretary-
Indian Affairs (Operations) on March 6, 1986, pursuant to
Section 16 of the Act of June 18, 1934 (48 Stat. 984).



4 submittal.


